MAKING AN APPROPRIATION FOR FINAL ENGINEERING AND RIGHT-OF-WAY ACQUISITION RELATED TO ROAD AND DRAINAGE IMPROVEMENTS ON ISLETA BOULEVARD IN BERNALILLO COUNTY; DECLARING AN EMERGENCY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION.--Six hundred seventy-five thousand dollars (\$675,000) is appropriated from the general fund to the state highway and transportation department for expenditure in fiscal years 1996 and 1997 for the purpose of final engineering and right-of-way acquisition related to constructing road and drainage improvements on Isleta boulevard from Rio Bravo boulevard to Bridge street in Bernalillo county. This appropriation is contingent upon the county of Bernalillo providing six hundred seventy-five thousand dollars (\$675,000) in matching funds to the project. Any unexpended or unencumbered balance remaining at the end of fiscal year 1997 shall revert to the general fund.

Section 2. EMERGENCY.--It is necessary for the public peace, health and safety that this act take effect immediately.
