Section 1. APPROPRIATION.--Two million four hundred thirty-two thousand dollars (\$2,432,000) is appropriated from the general fund to the state highway and transportation department for expenditure in fiscal years 1996 and 1997 for the purposes of obtaining a right of way and for construction on ninety-eighth street between Benavides road southwest and Central avenue in Albuquerque. Any unexpended or unencumbered balance remaining at the end of fiscal year 1997 shall revert to the general fund.

Section 2. EMERGENCY.--It is necessary for the public peace, health and safety that this act take effect immediately.
