RELATING TO PUBLIC ASSISTANCE; PROVIDING A MORATORIUM ON REDUCTIONS IN PAYMENTS AND SERVICES; DECLARING AN EMERGENCY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Services in Certain Public Assistance programs. --In any program of assistance or services administered by the human services department in which the budgeted expenditures for the program include amounts from general fund appropriations, the department shall not, during the period from the effective date of this section until October 1, 1997, reduce the level of assistance or services from the level existing on January 1, 1996, by:

A. changing eligibility requirements to raise the threshold of eligibility for an individual or family to receive assistance or services; or
