AN ACT

MAKING AN APPROPRIATION TO THE NEW MEXICO OFFICE OF INDIAN AFFAIRS FOR MANAGEMENT SERVICES FOR NATURAL DISASTERS AND CHEMICAL EMERGENCIES IN THE NAVAJO NATION; DECLARING AN EMERGENCY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION. --Three hundred thousand dollars (\$300,000) is appropriated from the general fund to the New Mexico office of Indian affairs for expenditure in fiscal years 1996 and 1997 for the purpose of funding management services for natural disasters and chemical emergencies in the Navajo nation. Any unexpended or unencumbered balance remaining at the end of fiscal year 1997 shall revert to the general fund.

Section 2. EMERGENCY. --It is necessary for the public peace, health and safety that this act take effect immediately.
