AN ACT

MAKING AN APPROPRIATION FOR PAVING AND FENCING PROJECTS IN TWIN LAKES IN MCKINLEY COUNTY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION. -- One hundred twenty thousand dollars (\$120,000) is appropriated from the general fund to the New Mexico office of Indian affairs for expenditure in fiscal year 1997 for the purpose of paving the Twin Lakes chapter house parking lot and Twin Lakes preschool parking lot and installing a fence around the Twin Lakes preschool. Any unexpended or unencumbered balance remaining at the end of fiscal year 1997 shall revert to the general fund.
