AN ACT

MAKING AN APPROPRIATION FOR A NEEDS ASSESSMENT FOR POST-
SECONDARY EDUCATIONAL SERVICES IN SANDOVAL COUNTY; DECLARING AN
EMERGENCY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION. --Forty thousand dollars
(\$40,000) is appropriated from the general fund to the
commission on higher education for expenditure in fiscal years
1996 and 1997 for the purpose of performing a needs assessment,
including identification of location, educational level and
number of students to be served, scope of courses and sources of
funding for post-secondary educational services to be located in
Sandoval county. Any unexpended or unencumbered balance
remaining at the end of fiscal year 1997 shall revert to the
general fund.
