AN ACT

RELATING TO EDUCATION; PROVIDING THAT TECHNICAL AND VOCATIONAL INSTITUTE DISTRICTS BE LIMITED TO CERTAIN CLASS A COUNTIES; PROVIDING FOR TRANSFER OF SPECIAL ASSESSMENT PROCEEDS; MAKING AN APPROPRIATION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. A new section of the Technical and Vocational Institute Act is enacted to read:

"[NEW MATERIAL] TECHNICAL AND VOCATIONAL INSTITUTE IN CERTAIN CLASS A COUNTIES. -- Notwithstanding any other provisions of the Technical and Vocational Institute Act, no technical and vocational institute district that includes a class A county with assessed valuation in excess of four hundred million dollars (\$400,000,000) shall include any territory outside the class A county."

Section 2. TEMPORARY PROVISION -- TRANSFER OF SPECIAL ASSESSMENT. -- Proceeds derived from any special assessment levy in any county that, pursuant to this act, can no longer be included in a technical and vocational institute district in a class A county with an assessed valuation in excess of four hundred million dollars (\$400,000,000) shall be held in a segregated trust fund by the district. The trust fund shall be used for development of a community college or similar facilities in any county that is excluded from the district pursuant to this act. The fund shall be expended upon certification by the school boards located in any such counties.
