### A JOINT MEMORIAL

REQUESTING THE LEGISLATIVE EDUCATION STUDY COMMITTEE TO ANALYZE THE INFRASTRUCTURE NEEDS OF THE STATE'S PUBLIC SCHOOLS AND RECOMMEND IMPROVEMENTS TO THE LEGISLATURE IN ALLOCATING RESOURCES TO MEET THOSE NEEDS.

WHEREAS, public schools submitted requests to the public school capital outlay council for more than one hundred twentyseven million dollars (\$127,000,000) worth of capital improvements in fiscal year 1995; and

WHEREAS, the public school capital outlay council was able to fund only a fraction of those requests; and

WHEREAS, some of the critical needs of our public schools are illustrated by the school that is sinking in Pecos, a collapsed roof on a school in Hatch and the use of rejected army barracks for school classrooms in Gadsden;

NOW, THEREFORE, BE IT RESOLVED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO that the legislative education study committee analyze the infrastructure needs of New Mexico's public schools, review alternative funding methods to meet those needs and recommend to the legislature by January 1, 1997 improvements to the state's procedures for supporting school infrastructure needs and allocating the state's resources equitably statewide; and

BE IT FURTHER RESOLVED that copies of this memorial be transmitted to the legislative education study committee.
