WHEREAS, sometimes the judicial system is not able to act on commitment issues in a timely manner; and

WHEREAS, court-ordered treatment should always be determined by medical professionals with appropriate

participation by the individual subject to the order, his family and other legitimately interested parties;

NOW, THEREFORE, BE IT RESOLVED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO that the need to revise New Mexico's statutes related to mental illness and the mentally ill be studied by the department of health and recommendations be made to the interim legislative health and human services committee at its meeting in October 1996; and

BE IT FURTHER RESOLVED that statewide organizations for the mentally ill, mentally ill individuals, the state bar of New Mexico, the New Mexico district attorneys association, the office of the attorney general, the public defender department, the New Mexico office of Indian affairs, statewide medical organizations and statewide psychological organizations be invited to participate in the study; and

BE IT FURTHER RESOLVED that a copy of this memorial be sent to each named state agency and that the department of health invite the participation of the nongovernmental entities descri bed.
