A MEMORIAL

REQUESTING THAT THE TAXATION AND REVENUE DEPARTMENT, STATE CORPORATION COMMISSION AND TOURISM DEPARTMENT ESTABLISH COST-ACCOUNTING SYSTEMS TO ACCOUNT FOR THE ACTUAL USE OF STATE ROAD FUND REVENUES APPROPRIATED TO THEM FOR AGENCY OPERATIONS.

WHEREAS, approximately seventeen million dollars (\$17,000,000) from the state road fund is appropriated in the general appropriation act each year for state agency operations; and

WHEREAS, these agencies include the taxation and revenue department, the state corporation commission and the tourism department; and

WHEREAS, the legislature needs information on the actual use of state road fund revenues to determine if the uses are appropriately and directly related to collection or

1 administration of road, motor vehicle or motor transportation
2 taxes and fees; and

3 WHEREAS, a cost-accounting system that identifies actual
4 costs and expenditures paid with state road fund revenues would
5 provide necessary information to the legislature in determining
6 whether such appropriations of the state road fund should be
7 continued;

8 NOW, THEREFORE, BE IT RESOLVED BY THE LEGISLATURE OF THE
9 STATE OF NEW MEXICO that it request the taxation and revenue
10 department, the state corporation commission and the tourism
11 department to establish a cost-accounting system to account for
12 use of state road fund revenues appropriated to the agencies for
13 agency operations; and

14 BE IT FURTHER RESOLVED that these agencies report on the
15 cost-accounting systems they establish and the findings from
16 that cost-accounting to the legislative finance committee and to
17 the first session of the forty-third legislature; and

18 BE IT FURTHER RESOLVED that a copy of this memorial be
19 transmitted to the secretary of taxation and revenue, the
20 chairman of the state corporation commission, the secretary of
21 tourism and the chairman of the legislative finance committee.
