WHEREAS, the Texas legislature lowered nonresident tuition for students who reside in a state with a common border with Texas and reside within one hundred thirty-five miles of the Texas border; and

WHEREAS, Texas provides for a nonresident to pay resident tuition if the neighboring state reciprocates; and

WHEREAS, many New Mexico residents live closer to Texas post-secondary institutions than to New Mexico post-secondary institutions; and

WHEREAS, New Mexico post-secondary institutions may gain students from such a provision;

NOW, THEREFORE, BE IT RESOLVED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO that the commission on higher education be requested to study the potential for providing lower tuition for nonresident students from Texas or other neighboring states that provide reciprocal agreements and to report to the legislative education study committee with its recommendations by December 1, 1996; and

BE IT FURTHER RESOLVED that copies of this memorial be transmitted to the commission on higher education and to the legislative education study committee.
