APPROPRIATION.--One million three hundred thousand dollars (\$1,300,000) is appropriated from the general fund to the taxation and revenue department for expenditure in fiscal year 1997 for the purpose of making payments to the information systems division of the general services department for expenses incurred for use of the ONGARD system. Any unexpended or unencumbered balance remaining at the end of
