BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION. -- Twenty-five thousand dollars  
(\$25,000) is appropriated from the general fund to the  
department of environment for expenditure in fiscal year 1998  
for the purpose of planning and designing water system  
improvements for the Desert Aire community in Dona Ana county.  
Any unexpended or unencumbered balance remaining at the end of  
fiscal year 1998 shall revert to the general fund.
