MAKING AN APPROPRIATION TO THE ECONOMIC DEVELOPMENT DEPARTMENT
TO EXPAND RURAL COMMUNITY ACCESS TO TELECOMMUNICATIONS
TECHNOLOGY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION. -- Five hundred thousand dollars
(\$500,000) is appropriated from the general fund to the economic
development department for expenditure in fiscal year 1998 for
the purpose of contracting for the provision of computer
hardware, computer software, technology-related expertise and
related infrastructure that will expand rural community access
to telecommunications technology. Any unexpended or
unencumbered balance remaining at the end of fiscal year 1998
shall revert to the general fund.
