AN ACT

MAKING AN APPROPRIATION FOR RESEARCH AND PUBLIC SERVICE PROJECTS
AT THE UNIVERSITY OF NEW MEXICO HEALTH SCIENCES CENTER.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION. --

A. One million six hundred thirty-nine thousand one hundred dollars (\$1,639,100) is appropriated from the general fund to the board of regents of the university of New Mexico for expenditure in fiscal year 1998 in the following amounts for the following purposes:

(1) three hundred eighty-nine thousand five hundred dollars (\$389,500) to hire additional staff to support research objectives at the health sciences center;

(2) three hundred eighty-one thousand five hundred dollars (\$381,500) to continue and expand the enrollment

1 of the certified nurse-midwifery program at the health sciences
2 center;

3 (3) four hundred six thousand dollars (\$406,000)
4 for equipment costs and additional staff for the telemedicine
5 program;

6 (4) one hundred two thousand eight hundred
7 dollars (\$102,800) to fund additional staff positions and other
8 costs for the nurse distance education program; and

9 (5) three hundred fifty-nine thousand three
10 hundred dollars (\$359,300) for coordinating and increasing
11 support for area health education programs.

12 B. Any unexpended or unencumbered balance remaining
13 at the end of fiscal year 1998 shall revert to the general fund.
