AN ACT

RELATING TO CAPITAL EXPENDITURES; CHANGING THE PURPOSE OF A SEVERANCE TAX BOND APPROPRIATION TO THE DEPARTMENT OF ENVIRONMENT; MAKING AN APPROPRIATION TO THE STATE ENGINEER FOR ACEQUIA DE LA CIENEGA IMPROVEMENTS IN SANTA FE COUNTY; DECLARING AN EMERGENCY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. SEVERANCE TAX BONDS--CHANGE OF AGENCY--CHANGE IN PURPOSE--APPROPRIATION.--The balance of the proceeds from severance tax bonds appropriated to the department of environment pursuant to Subsection X of Section 6 of Chapter 4 of Laws 1996 (1st S.S.) for the purpose of installing a water system extension, including necessary improvements, to the village of La Cienega water system located in Santa Fe county shall not be expended for that purpose but is reauthorized and
