AN ACT

MAKING AN APPROPRIATION FOR PROGRAMS FOR AT-RISK YOUTH IN TAOS COUNTY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION. -- One hundred six thousand dollars (\$106,000) is appropriated from the general fund to the human services department for expenditure in fiscal year 1998 for the purpose of developing a youth corps program in Taos county, which will teach at-risk youth marketable skills, help them earn their graduate equivalency diplomas and otherwise offer a healthy alternative to youth incarceration. Any unexpended or unencumbered balance remaining at the end of fiscal year 1998 shall revert to the general fund.
