AN ACT

RELATING TO MOTOR VEHICLES; REQUIRING THE ISSUANCE OF INSURANCE EXCHANGE CARDS; ENACTING A SECTION OF THE MANDATORY FINANCIAL RESPONSIBILITY ACT.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. A new section of the Mandatory Financial Responsibility Act is enacted to read:

" NEW MATERIAL INSURANCE EXCHANGE CARDS. --

A. The director shall adopt and promulgate regulations requiring insurance carriers to provide insurance cards to policyholders to be exchanged with another driver or provided to a law enforcement officer in the event of a motor vehicle accident.

B. The insurance exchange cards shall include, but not be limited to, the following information:

- (1) the registered owner of the motor vehicle;
- (2) a vehicle description;
- (3) the vehicle identification number;
- (4) the name and address of the insurance agent;
- (5) the name of the insurance company;
- (6) the insurance policy number; and
- (7) the policy expiration date.

C. Insurance exchange cards containing current information shall be provided to policyholders with each new issuance of an evidence of financial responsibility card. "
