FOR ONE MAGISTRATE COURT IN MCKINLEY MAGISTRATE DISTRICT TO SIT
IN GALLUP.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. Section 35-1-20 NMSA 1978 (being Laws 1968,
Chapter 62, Section 22, as amended) is amended to read:

"35-1-20. MAGISTRATE COURT-- MCKINLEY DISTRICT. -- There
shall be three magistrates in McKinley magistrate district,
divisions 1 [~~and 2~~], 2 and 3 operating as a single court in
Gallup [~~and division 3 in Thoreau~~]. "
