AN ACT

RELATING TO CAPITAL EXPENDITURES; EXTENDING THE EXPENDITURE PERIOD OF A STATE ROAD FUND APPROPRIATION TO CIBOLA COUNTY; MAKING AN APPROPRIATION; DECLARING AN EMERGENCY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. STATE ROAD FUND--EXTENDING EXPENDITURE PERIOD-- APPROPRIATION.--The period of time for expenditure of a state road fund appropriation made pursuant to Subsection B of Section 48 of Chapter 148 of Laws 1994 to design and construct a highway from state road 117 to the observatory site in Cibola county, contingent on the state receiving a United States department of defense award of not less than twelve million dollars (\$12,000,000) for development of an astronomy-oriented science center in New Mexico shall be extended through fiscal year 2000. Any unexpended or unencumbered balance remaining at the end of

1 fiscal year 2000 shall revert to the general fund.

2 Section 2. EMERGENCY.--It is necessary for the public
