RELATING TO HEALTH CARE; REQUIRING COVERAGE UNDER MEDICAID FOR  
PROFESSIONAL LICENSED COUNSELOR AND THERAPIST PRACTITIONERS;  
ENACTING A NEW SECTION OF THE PUBLIC ASSISTANCE ACT.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. A new section of the Public Assistance Act is  
enacted to read:

" [NEW MATERIAL] MEDICAID COVERAGE FOR LICENSED  
PROFESSIONAL COUNSELOR AND THERAPIST PRACTITIONERS. -- The  
medicaid program shall include coverage for the mental health  
services offered by, and shall provide payments for mental  
health services rendered to medicaid patients by, all licensed,  
professional clinical mental health counselors, marriage and  
family therapists, professional art therapists and professional  
mental health counselors as these practitioners are defined in

2 practitioners shall be required to be supervised by other health  
3 care providers in order to qualify for payment under the
