AN ACT

RELATING TO MOTOR VEHICLES; PROVIDING FOR SPECIAL LOS HIJOS
HIDALGO DE NUEVO MEXICO REGISTRATION PLATES

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. A new section of the Motor Vehicle Code is
enacted to read:

"~~[NEW MATERIAL]~~ SPECIAL LOS HIJOS HIDALGOS DE NUEVO MEXICO
REGISTRATION PLATES-- PROCEDURES-- FEE. --

A. The department shall establish and issue special
Los Hijos Hidalgo de Nuevo Mexico registration plates for any
private motor vehicle except a motorcycle. The department shall
adopt procedures for application for and issuance of the special
Los Hijos Hidalgo de Nuevo Mexico registration plates.

B. The department shall determine the color and
design of the registration plate and provide for its issuance.

1 No personalized or vanity design variation of the special Los
2 Hijos Hidalgo de Nuevo Mexico registration plates shall be
3 issued.

4 C. For a fee of thirty-five dollars (\$35.00), which
5 shall be in addition to the regular motor vehicle registration
6 fees, any owner of a motor vehicle may apply for the issuance of
7 a special Los Hijos Hidalgo de Nuevo Mexico registration plate,
8 provided that the owner's surname is Hidalgo or the owner can
9 prove to the satisfaction of the department that he has the
10 Hidalgo surname in his lineage. The owner of a motor vehicle
11 shall apply for and pay a renewal fee of ten dollars (\$10.00)
12 for each subsequent year if he wishes to retain and renew a
13 special Los Hijos Hidalgo de Nuevo Mexico registration plate. "
