AN ACT

RELATING TO PUBLIC SCHOOLS; REQUIRING SPECIALIZED CULTURAL  
TRAINING FOR CERTIFIED SCHOOL PERSONNEL AND SCHOOL NURSES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. Section 22-10-3.2 NMSA 1978 (being Laws 1988,  
Chapter 48, Section 1, as amended) is amended to read:

"22-10-3.2. CERTIFIED SCHOOL PERSONNEL AND SCHOOL  
NURSES--REQUIRED TRAINING [~~PROGRAM~~] PROGRAMS. --

A. All certified school personnel and school nurses  
shall be required to complete training in the detection and  
reporting of child abuse and neglect and substance abuse. This  
requirement shall be completed within the person's first year of  
employment by a school district in the state.

B. All certified school personnel and school nurses  
shall be required to complete a specialized cultural training

1 course designed to help certified school personnel and nurses  
2 teach minority students more effectively. This requirement  
3 shall be completed within the person's first year of employment  
4 by a school district in the state.

5 [B-] C. Pursuant to the policy and regulations  
6 adopted by the state board, the department of education shall  
7 develop [a] training [~~program~~] programs, including training  
8 materials and necessary training staff, to meet the requirement  
9 of [~~Subsection A~~] Subsections A and B of this section to make  
10 the training available in every school district in the state.  
11 The department of education shall coordinate the development of  
12 the [~~program~~] programs with appropriate staff at the human  
13 services department [~~and~~], the department of health and any  
14 other appropriate state agency or department.

15 [C-] D. The training [~~program~~] programs developed  
16 pursuant to this section shall be made available by the  
17 department of education to the deans of every college of  
18 education in New Mexico for use in providing such training to  
19 students seeking elementary and secondary education  
20 certification. "
