AN ACT

MAKING AN APPROPRIATION TO THE STATE DEPARTMENT OF PUBLIC  
EDUCATION TO CONTRACT FOR EDUCATIONAL PROGRAMS AND SERVICES FOR  
THE SANTA FE PUBLIC SCHOOLS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION. -- Eighty-five thousand dollars  
(\$85,000) is appropriated from the general fund to the state  
department of public education for expenditure in fiscal year  
1998 for the purpose of contracting for the provision of  
outreach programs, school volunteer programs, community field  
trips and creative classroom projects for the Santa Fe public  
schools; provided that the state department of public education  
shall contract with an organization that provides educational  
services to public schools and that has been granted an  
exemption from federal income tax by the United States

1 commissioner of internal revenue as an organization described in  
2 Section 501 (c)(3) of the United States Internal Revenue Code of  
3 1986, as amended or renumbered. Any unexpended or unencumbered
