AN ACT

RELATING TO THE PUBLIC PEACE, HEALTH, SAFETY AND WELFARE; MAKING APPROPRIATIONS FOR THE PURPOSE OF CARRYING OUT THE PROVISIONS OF THE FAMILY ASSISTANCE AND INDIVIDUAL RESPONSIBILITY ACT; PROVIDING FOR THE MAINTENANCE OF EFFORT REQUIRED TO OBTAIN THE FEDERAL TEMPORARY ASSISTANCE FOR NEEDY FAMILIES BLOCK GRANT.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATIONS. --

A. Contingent upon the enactment into law of the Family Assistance and Individual Responsibility Act by the first session of the forty-third legislature:

(1) one hundred twenty-eight million dollars (\$128,000,000) is appropriated from federal funds pursuant to Section 901 of the federal Personal Responsibility and Work Opportunity Reconciliation Act of 1996, Public Law 104-193, to

1 the human services department for expenditure in fiscal year
2 1998 for the purpose of carrying out the provisions of the
3 Family Assistance and Individual Responsibility Act. Any
4 unexpended or unencumbered balance remaining at the end of
5 fiscal year 1998 shall not revert; and

6 (2) thirty-five million dollars (\$35,000,000)
7 is appropriated from the general fund to the human services
8 department for expenditure in fiscal year 1998 for the purpose
9 of carrying out the provisions of the Family Assistance and
10 Individual Responsibility Act. Any unexpended or unencumbered
11 balance remaining at the end of fiscal year 1998 shall revert to
12 the general fund.

13 B. The appropriation in Paragraph (2) of Subsection
14 A of this section, together with other appropriations to the
15 human services department, the children, youth and families
16 department and the labor department in the General Appropriation
17 Act of 1997, shall be used to meet the one hundred percent of
18 the maintenance of effort required to obtain both the federal
19 temporary assistance for needy families block grant and its
20 contingency pursuant to the federal Personal Responsibility and
21 Work Opportunity Reconciliation Act of 1996, Public Law 104-193.

22 C. The appropriations authorized in this section
23 shall only take effect if the Family Assistance and Individual
24 Responsibility Act is enacted into law by the first session of
25 the forty-third legislature.
