AN ACT

RELATING TO THE PUBLIC PEACE, HEALTH, SAFETY AND WELFARE; MAKING AN APPROPRIATION FOR THE CUARTOCENTENNIAL COMMEMORATIVE CELEBRATION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION. --Two hundred thousand dollars (\$200,000) is appropriated from the general fund to the board of regents of the university of New Mexico for the center for regional studies at the university of New Mexico for expenditure in fiscal years 1998 and 1999 for the purpose of planning, initiating and partially implementing an informational and educational cuartocentennial commemoration, to celebrate the four hundredth anniversary of the founding of New Mexico through historical and educational presentations. Any unexpended or unencumbered balance remaining at the end of fiscal year 1999
