RELATING TO THE DWI OVERSIGHT TASK FORCE; EXTENDING THE TENURE
OF THE DWI OVERSIGHT TASK FORCE; AMENDING SECTIONS OF THE NMSA
1978.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. Section 2-12-6 NMSA 1978 (being Laws 1993,
Chapter 65, Section 15) is amended to read:

"2-12-6. DWI OVERSIGHT TASK FORCE CREATED--
TERMINATION.--The "DWI oversight task force" is created. The
task force shall function from the date of its appointment until
the first day of December prior to the [~~second session of the
forty-third legislature~~] first session of the forty-fourth
legislature."

Section 2. Section 2-12-9 NMSA 1978 (being Laws 1993,
Chapter 65, Section 18) is amended to read:

1 "2-12-9. REPORT.--The DWI oversight task force shall make
2 a report of its findings and recommendations for the
3 consideration of the second session of the forty-first
4 legislature, the first session of the forty-second legislature,
5 the second session of the forty-second legislature, the first
6 session of the forty-third legislature, [~~and~~] the second session
7 of the forty-third legislature and the first session of the
8 forty-fourth legislature. The reports and suggested legislation
9 shall be made available to the New Mexico legislative council on
10 or before December 15 preceding each session. "

11 Section 3. EFFECTIVE DATE.--The effective date of the
12 provisions of this act is July 1, 1997.
