AN ACT

MAKING AN APPROPRIATION FOR THE SUPPORT OF CERTAIN HOMELESS PROGRAMS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION. -- Two hundred sixty-six thousand seven hundred twenty dollars (\$266,720) is appropriated from the general fund to the department of health for expenditure in fiscal year 1998 for the purpose of supporting homeless programs in any class A county with a population of fewer than four hundred thousand persons. Any unexpended or unencumbered balance remaining at the end of fiscal year 1998 shall revert to the general fund.
