RELATING TO ELECTIONS; ENACTING A NEW SECTION OF THE ELECTION CODE; REQUIRING REMOVAL OF DECEASED CANDIDATE' S NAME FROM THE BALLOT.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. BALLOTS--REMOVAL OF NAME OF DECEASED

CANDIDATE. --The name of a candidate deceased after the filing of his declaration of candidacy and nominating petitions, after the designation by a pre-primary convention or after his nomination at a primary election, but prior to the printing of the primary or general election ballot, shall be removed from the primary or general election ballot.
