AN ACT

MAKING APPROPRIATIONS TO ESTABLISH TRADE OFFICES IN BEIJING,  
PEOPLE'S REPUBLIC OF CHINA; TAIPEI, REPUBLIC OF CHINA; AND  
TOKYO, JAPAN.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION. --Two hundred fifty thousand  
dollars (\$250,000) is appropriated from the general fund to the  
economic development department for expenditure in fiscal year  
1998 for the purpose of providing personal services, supplies,  
materials or contractual services necessary to establish a trade  
office in the city of Beijing, People's Republic of China. Any  
unexpended or unencumbered balance remaining at the end of  
fiscal year 1998 shall revert to the general fund.

Section 2. APPROPRIATION. --Two hundred fifty thousand  
dollars (\$250,000) is appropriated from the general fund to the
