AN ACT

RELATING TO CAPITAL EXPENDITURES; MAKING AN APPROPRIATION FOR THE PURCHASE OF A BOMB ROBOT FOR THE POLICE DEPARTMENT OF THE CITY OF ALBUQUERQUE IN BERNALILLO COUNTY; DECLARING AN EMERGENCY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION. --One hundred seventy-five thousand dollars (\$175,000) is appropriated from the general fund to the local government division of the department of finance and administration for expenditure in fiscal years 1997 and 1998 for the purchase of a bomb robot for the police department of the city of Albuquerque in Bernalillo county. Any unexpended or unencumbered balance remaining at the end of fiscal year 1998 shall revert to the general fund.

Section 2. EMERGENCY. --It is necessary for the public
