AN ACT

RELATING TO CAPITAL EXPENDITURES; AUTHORIZING THE ISSUANCE OF SEVERANCE TAX BONDS TO PURCHASE WALK-IN COOLERS FOR DONATED FOOD PROGRAMS IN NORTHWESTERN NEW MEXICO IN SAN JUAN AND MCKINLEY COUNTIES; MAKING AN APPROPRIATION; DECLARING AN EMERGENCY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. SEVERANCE TAX BONDS--PURPOSE FOR WHICH ISSUED-- APPROPRIATION OF PROCEEDS.--The state board of finance may issue and sell severance tax bonds in compliance with the Severance Tax Bonding Act in an amount not exceeding twenty-two thousand dollars (\$22,000) when the New Mexico office of Indian affairs certifies the need for the issuance of the bonds. The state board of finance shall schedule the issuance and sale of the bonds in the most expeditious and economical manner possible upon a finding by the board that the project has been developed

1 sufficiently to justify the issuance and that the project can  
2 proceed to contract within a reasonable time. The state board  
3 of finance shall further take the appropriate steps necessary to  
4 comply with the Internal Revenue Code of 1986, as amended. The  
5 proceeds from the sale of the bonds are appropriated to the New  
6 Mexico office of Indian affairs for the purpose of purchasing  
7 and installing two walk-in coolers for donated food programs in  
8 Kirtland and Mexican Springs located in San Juan and McKinley  
9 counties. Any unexpended or unencumbered balance remaining at  
10 the end of fiscal year 2000 shall revert to the severance tax  
11 bonding fund. If the New Mexico office of Indian affairs has  
12 not certified the need for the issuance of the bonds by the end  
13 of fiscal year 1999, the authorization provided in this section  
14 shall be void.

15 Section 2. EMERGENCY. --It is necessary for the public  
16 peace, health and safety that this act take effect immediately.
