AN ACT

MAKING AN APPROPRIATION FOR HOME CARE SERVICES TO THE ELDERLY  
AND HANDICAPPED IN SOCORRO COUNTY; DECLARING AN EMERGENCY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION. -- Fifteen thousand dollars  
(\$15,000) is appropriated from the general fund to the state  
agency on aging for expenditure in fiscal years 1997 and 1998  
for the purpose of contracting for home care services to elderly  
and handicapped persons in Socorro county. Any unexpended or  
unencumbered balance remaining at the end of fiscal year 1998  
shall revert to the general fund.

Section 2. EMERGENCY. -- It is necessary for the public  
peace, health and safety that this act take effect immediately.
