MAKING AN APPROPRIATION FOR SUPPORT OF THE COMMUNITIES IN THE  
SCHOOLS PROGRAM

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION. -- Two hundred fifty thousand  
dollars (\$250,000) is appropriated from the general fund to the  
state department of public education for expenditure in fiscal  
year 1998 for the purpose of supporting the communities in the  
schools program to increase parental and community involvement  
in public school education. Any unexpended or unencumbered  
balance remaining at the end of fiscal year 1998 shall revert to  
the general fund.
