AN ACT

RELATING TO COMMUNITY COLLEGES; AUTHORIZING A COMMUNITY COLLEGE BOARD TO ESTABLISH A CAMPUS POLICE FORCE; PROVIDING FOR THE AUTHORITY OF THE CAMPUS POLICE THUS ESTABLISHED.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. A new section of Chapter 29, Article 5 NMSA 1978 is enacted to read:

"[NEW MATERIAL] COMMUNITY COLLEGES--BOARDS AUTHORIZED TO ESTABLISH CAMPUS POLICE FORCE--QUALIFICATIONS AND AUTHORITY OF CAMPUS POLICE OFFICERS.--

A. The community college board of a community college established pursuant to the Community College Act may adopt and promulgate traffic regulations to apply to areas within the exterior boundaries of the lands under control of the board, including streets and highways.

1 B. The community college board of a community
2 college established pursuant to the Community College Act may
3 employ and assign duties to persons as campus police officers
4 for the community college.

5 C. Persons employed as campus police officers by a
6 community college board:

7 (1) shall have the powers of peace officers
8 within the exterior boundaries of lands under the control of the
9 board, including streets and highways;

10 (2) shall at all times while on duty carry
11 commissions of office issued by the board;

12 (3) may enforce all applicable laws, ordinances
13 and campus traffic regulations within the territory in which
14 they have powers of peace officers; and

15 (4) may make arrests for violations of laws,
16 ordinances and campus traffic regulations that they have
17 authority to enforce, but no arrest is valid unless the
18 arresting campus police officer is at the time of the arrest
19 wearing:

20 (a) a distinctive badge issued to him by
21 the community college board and bearing the name of the
22 community college; and

23 (b) a distinctive uniform prescribed and
24 issued to him by the board. "
