AN ACT

RELATING TO GAME AND FISH; AMENDING A SECTION OF THE NMSA 1878  
PERTAINING TO DEFINITION OF RESIDENT FOR PURPOSES OF PURCHASING  
A HUNTING AND FISHING LICENSE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. Section 17-3-4 NMSA 1978 (being Laws 1964 (1st  
S.S.), Chapter 17, Section 4, as amended) is amended to read:

"17-3-4. RESIDENCE. -- As used in Chapter 17 NMSA 1978:

A. a "resident" entitled to purchase resident  
hunting and fishing licenses is any person:

(1) who is a United States citizen and who, for  
a period of not less than ninety days immediately preceding the  
date of application for the license, has been domiciled in New  
Mexico and has not claimed residency elsewhere for any purpose;

(2) who is not a citizen of the United States

1 but who is legally within the United States and has actually  
2 lived in this state for ninety days immediately preceding his  
3 license application;

4 (3) not otherwise entitled to claim residence,  
5 who is a student attending any educational institution in this  
6 state, has so attended and actually lived in this state for at  
7 least one full term immediately preceding his license  
8 application and presents with his application a certificate of  
9 such attendance from proper authorities of the educational  
10 institution;

11 (4) not otherwise entitled to claim residence,  
12 who is a member of the armed forces of the United States and  
13 permanently assigned to a military installation located within  
14 this state and presents with his license application a  
15 certificate of such assignment from his commanding officer or  
16 designated representative, or the spouse or dependent of such  
17 person, not otherwise entitled to claim residence, living within  
18 the same household and similarly certified by the person's  
19 commanding officer; [øø]

20 (5) not otherwise entitled to claim residence,  
21 who is a member of the armed forces of the United States and  
22 officially stationed at a military reservation located partially  
23 in this state and partially in an adjacent state, but only for a  
24 special license valid only for hunting and fishing in this state  
25 on those reservations; [and] or

(6) not otherwise entitled to claim residence,  
who has paid a New Mexico individual income or property tax

B. a "nonresident" who must purchase nonresident

including any temporary resident who maintains his home outside  
of the state."
