AN ACT

MAKING AN APPROPRIATION FOR THE INSTITUTE OF INTERCULTURAL
COMMUNITY LEADERSHIP AT THE SANTA FE COMMUNITY COLLEGE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION. -- One hundred eighty thousand
dollars (\$180,000) is appropriated from the general fund to the
community college board of Santa Fe community college for
expenditure in fiscal year 1998 for the purpose of conducting
joint planning and problem solving for educational reform with
the Santa Fe public schools at the institute for intercultural
community leadership at the Santa Fe community college. Any
unexpended or unencumbered balance remaining at the end of
fiscal year 1998 shall revert to the general fund.
