AN ACT

RELATING TO WORKERS' COMPENSATION; ENACTING A NEW SECTION OF THE MUNICIPAL CODE TO AUTHORIZE MUNICIPALITIES TO REVOKE ROOFING BUILDING PERMITS WHEN WORKERS' COMPENSATION COVERAGE IS NOT MAINTAINED.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. A new section of the Municipal Code is enacted to read:

"[NEW MATERIAL] ROOFING CONTRACTOR--WORKERS' COMPENSATION COVERAGE--BUILDING PERMIT REVOCATION. --A municipality may revoke the building permit of a construction project if the roofing contractor has not complied with the provisions of the Workers' Compensation Act. "
