AN ACT

RELATING TO HEALTH CARE; REQUIRING MAMMOGRAMS FOR MEDICAID
RECIPIENTS TO CONFORM TO CERTAIN STANDARDS; ENACTING A NEW
SECTION OF THE PUBLIC ASSISTANCE ACT.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. A new section of the Public Assistance Act is
enacted to read:

"[NEW MATERIAL] MAMMOGRAMS FOR MEDICAID RECIPIENTS. -- In
providing coverage for ~~mammograms~~ under the ~~medicaid~~ program,
the department shall ensure that:

A. the solicitation of patients for ~~mammograms~~ shall
be determined by the department after taking into consideration
the recommendations of nationally recognized ~~medical~~
organizations; and

B. the payment that shall be ~~made~~ on behalf of the
