AN ACT

MAKING AN APPROPRIATION TO ESTABLISH SATELLITE OFFICE OF THE NEW MEXICO OFFICE OF INDIAN AFFAIRS IN SHIPROCK IN SAN JUAN COUNTY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION. -- Fifty thousand dollars (\$50,000) is appropriated from the general fund to the New Mexico office of Indian affairs for expenditure in fiscal year 1998 for the purpose of establishing a satellite office of the New Mexico office of Indian affairs in Shiprock in San Juan county. Any unexpended or unencumbered balance remaining at the end of fiscal year 1998 shall revert to the general fund.
