A JOINT MEMORIAL

REQUESTING THE STATE DEPARTMENT OF PUBLIC EDUCATION, THE
LEGISLATIVE EDUCATION STUDY COMMITTEE AND THE NEW MEXICO SCHOOL
SUPERINTENDENTS ASSOCIATION TO COOPERATE IN A STUDY OF SCHOOL
TRANSPORTATION LAWS AND REGULATIONS AS THEY AFFECT PUBLIC
SCHOOLS.

WHEREAS, House Bill 679, as amended, of the first session
of the forty-third legislature, proposes a significant change in
the manner of funding school transportation that negatively
impacts the majority of the school districts; and

WHEREAS, the current funding formula for school
transportation has not been fair and equitable to school
districts; and

WHEREAS, the school districts need an opportunity to
provide input into the process and assist the above-mentioned

1 agencies in seeking a fair and equitable process for funding
2 transportation;

3 NOW, THEREFORE, BE IT RESOLVED BY THE LEGISLATURE OF THE
4 STATE OF NEW MEXICO that the state transportation division of
5 the state department of public education be requested to
6 cooperate with the school superintendents and legislative
7 education study committee in studying the policy and procedures
8 involved in the funding of school transportation; and

9 BE IT FURTHER RESOLVED that the state transportation
10 division of the state department of public education make
11 recommendations to the legislature by December 1, 1997 for
12 legislation needed to foster development of effective, efficient
13 and economical school transportation funding; and

14 BE IT FURTHER RESOLVED that copies of this memorial be
15 transmitted to the state department of public education, the
16 legislative education study committee and the New Mexico school
17 superintendents association.
