A JOINT RESOLUTION

PROPOSING TO AMEND ARTICLE 8 OF THE CONSTITUTION OF NEW MEXICO BY ADDING A NEW SECTION TO PROHIBIT INCREASES IN THE VALUE OF PROPERTY FOR PROPERTY TAXATION PURPOSES OF THE PRINCIPAL PLACE OF RESIDENCE OF A PERSON SIXTY-FIVE YEARS OF AGE OR OLDER.

BE IT RESOLVED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. It is proposed to amend Article 8 of the constitution of New Mexico by adding a new section to read:

"The legislature shall provide by law for prohibiting increases in the valuation of residential property owned by a person sixty-five years of age or older who occupies the property as his principal place of residence. The valuation for property taxation purposes for any property tax year of property that qualifies for this valuation cap shall not exceed its valuation for property tax purposes for the 1998 property tax

year or the property tax year in which the taxpayer first qualifies for the valuation cap, whichever is later. The valuation cap shall apply until the property tax year following the year in which the property is no longer the taxpayer's principal place of residence or the taxpayer no longer owns the property."

Section 2. The amendment proposed by this resolution shall be submitted to the people for their approval or rejection at the next general election or at any special election prior to that date which may be called for that purpose.
