20	second Tuesday of March. Every regular session of the					
21	legislature convening during an odd-numbered year shall remain					
22	in session not to exceed sixty days, and every regular session					
23	of the legislature convening during an even-numbered year shall					
24	remain in session not to exceed thirty days. No special session					
25	of the legislature shall exceed thirty days.
