AN ACT

**RELATING TO DISTRICT ATTORNEYS; CREATING THE DISTRICT ATTORNEY
FUND; MAKING AN APPROPRIATION; DECLARING AN EMERGENCY.**

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

**Section 1. DISTRICT ATTORNEY FUND--CREATED--
ADMINISTRATION--PURPOSE.--**

**A. The "district attorney fund" is created in the
state treasury. The fund shall consist of worthless check
fees, preprosecution diversion fees, other statutory revenues
directed to the fund, appropriations, gifts, grants and
donations.**

**B. Money in the fund is appropriated to the
administrative office of the district attorneys for the sole
purpose of meeting necessary expenses incurred in the
operation of the administrative office of the district**

2 C. Expenditures from the fund shall be pursuant to
3 budgets approved by the state budget division of the
4 department of finance and administration and made by warrant
5 drawn by the secretary of finance and administration pursuant
6 to vouchers signed by the director of the administrative
7 office of the district attorneys or his authorized
8 representative.

9 D. The fund shall not revert at the end of any
10 fiscal year.

11 Section 2. EMERGENCY.--It is necessary for the public
12 peace, health and safety that this act take effect
13 immediately.
