AN ACT

**MAKING AN APPROPRIATION TO REPAY A LOAN FROM THE CAPITOL
BUILDINGS REPAIR FUND FOR THE LIBRARY, ARCHIVES AND RECORDS
BUILDING PROJECT; DECLARING AN EMERGENCY.**

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

**Section 1. APPROPRIATION. --Two million three hundred
nine thousand dollars (\$2, 309, 000) is appropriated from the
general fund to the capitol buildings repair fund in fiscal
year 1998 to repay a loan authorized by the state board of
finance to complete the library, archives and records building
in Santa Fe. Money from this appropriation shall not revert
to the general fund.**

**Section 2. EMERGENCY. --It is necessary for the public
peace, health and safety that this act take effect
immediately.**
