AN ACT

MAKING AN APPROPRIATION TO FUND STATEWIDE HOMELESS PROGRAMS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION. -- One million five hundred thousand dollars (\$1,500,000) is appropriated from the general fund to the human services department for expenditure in fiscal year 1999 to provide or contract for community-based programs and services that provide homeless people with a continuum of care, including emergency shelter beds; services for veterans, the jobless, the mentally ill and victims of domestic violence; outreach for homeless not in shelters; transportation; transitional housing, including such service for homeless teenage mothers and alcoholics; and case management. Any unexpended or unencumbered balance remaining at the end of fiscal year 1999 shall revert to the general
