SERVICE ANNOUNCEMENTS REGARDING PREVENTION OF ALCOHOL ABUSE.**

**BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:**

**Section 1. APPROPRIATION. -- One hundred fifty thousand  
dollars (\$150,000) is appropriated from the general fund to the  
department of health for expenditure in fiscal year 1999 for  
the purpose of contracting for the production and distribution  
of a videotape, accompanying literature and related public  
service announcements regarding prevention of alcohol abuse.  
The videotape, accompanying literature and public service  
announcements shall be produced in both English and Spanish.  
Any unexpended or unencumbered balance remaining at the end of  
fiscal year 1999 shall revert to the general fund.**
