AN ACT

**MAKING AN APPROPRIATION FOR A MEDIA LITERACY PROGRAM
STATEWIDE.**

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION. --

**A. Four hundred fifty thousand dollars (\$450,000)
is appropriated from the general fund to the state department
of public education for expenditure in fiscal year 1999 for
the purpose of conducting a statewide media literacy program
including:**

- (1) expansion of media literacy as substance
abuse prevention;**
- (2) dissemination of technology and media
literacy programs;**
- (3) unique educational CD-ROM technology**

- 3 media literacy forum;
