AN ACT

MAKING AN APPROPRIATION FOR SEXUAL ABUSE PREVENTION AND
TREATMENT PROGRAMS SERVING SANTA FE AND NORTHERN NEW MEXICO.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION. --

A. Two hundred fifty thousand dollars (\$250,000)
is appropriated from the general fund to the behavioral health
services division of the department of health for expenditure
in fiscal year 1999 for the following purposes:

(1) one hundred twenty-five thousand dollars
(\$125,000) to fund a comprehensive, multicultural child sexual
abuse prevention program serving Santa Fe and northern New
Mexico for students in grades four through six; and

(2) one hundred twenty-five thousand dollars
(\$125,000) for a sexual abuse prevention program serving Santa
