AN ACT

RELATING TO CRIMINAL LAW; CREATING THE CRIMINAL OFFENSE OF
INJURY TO LIVESTOCK; PROVIDING PENALTIES; ENACTING A NEW
SECTION OF CHAPTER 30, ARTICLE 18 NMSA 1978.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. A new section of Chapter 30, Article 18 NMSA
1978 is enacted to read:

"[NEW MATERIAL] INJURY TO LIVESTOCK. --

A. Injury to livestock consists of willfully and
maliciously poisoning, killing or injuring livestock that is
the property of another.

B. As used in this section, "livestock" means
cattle, sheep, buffalo, horses, mules, goats, swine and
ratites.

C. Whoever commits injury to livestock is guilty
